

CDS Gen Bipin Rawat, wife and 11 others die in helicopter crash near Coonoor in Tamil Nadu

President, PM expresses grief over demise

Chennai, Dec.8
Chief of Defence Staff General Bipin Rawat has died in the air crash today. Indian Air Force statement said, General Bipin Rawat, his wife Madhulika Rawat and 11 other persons on board have died in the unfortunate accident.

An Indian Airforce helicopter Mi 17 V-5 carrying the Chief of Defence Staff Bipin Rawat and thirteen others crashed in the forest area near Coonoor in the Nilgiris District of Tamil Nadu today. Apart from the crew, CDS Bipin Rawat's staff and family members were also on board in the chopper which crashed. The passengers include Madhulika Rawat, President of Defence Wives Welfare Association, Brig.L.S.Lidder DA to CDS, Lt.Col. Harjinder Singh SO to CDS and five PSOs. The helicopter was on its way to the Sulur Airbase. Indian Air Force has said, an inquiry has been ordered to ascertain the cause of the accident.



The President, Prime Minister have expressed grief over demise of Gen Bipin Rawat. In a tweet, President, Shri Ram Nath Kovind said, he was shocked and anguished over the untimely demise of General Bipin Rawat and his wife. He said, the nation has lost one of its bravest sons. He paid tributes to each of those who died while performing their duty.

In a tweet, Prime Minister, Shri Narendra Modi said, General Bipin Rawat was an outstanding soldier, a true patriot, who greatly contributed to modernising armed forces and security apparatus. The Prime Minister said, General Bipin Rawat's insights and perspectives on strategic matters were exceptional. He said, as India's first Chief of Defence Staff, General Bipin Rawat worked on diverse aspects relating to our armed forces including defence reforms and brought with him a rich experience of serving in the Army. He said, India will never forget the exceptional service of General Bipin Rawat.

Vaccination drive in A&N Islands

5,68,584 doses of vaccines

administered to beneficiaries so far

Port Blair, Dec. 8
The safety of the citizens is the foremost priority of the Administration, especially during this pandemic time. To shield its citizens from the corona virus, the vaccination of eligible beneficiaries is being initiated by the Administration in different parts of the Islands.

Accordingly, the vaccination began with administering of COVISHIELD vaccine for Health Care Workers and vulnerable

population with comorbidities. Subsequently, the vaccination for 45 and above was initiated followed by 18 to 44 years which is currently underway.

Meanwhile, the vaccination drive is continuing smoothly in A&N Islands. As per data available, a total of 5,68,584 doses of vaccines have been administered to beneficiaries so far in A&N Islands, out of the target beneficiaries of 2,86,600 (approx.).

A total of 2618 people were vaccinated today. 2348 beneficiaries were

vaccinated in South Andaman District, out of which, 85 beneficiaries were in the age group of 18-44 years. Similarly, 250 beneficiaries were vaccinated in North & Middle Andaman District, out of which, 12 beneficiaries were in the age group of 18-44. 20 beneficiaries were vaccinated in Nicobar District, out of which, 2 beneficiaries were in the age group of 18-44. A total of 1,76,499 eligible people in the age group of 18 to 44 years have been vaccinated till date, a press release from DHS said.

General Bipin Rawat was an alumnus of National Defence Academy, Defence Services Staff College and National Defence College. He was commissioned on 16th December in 1978 into the Fifth Battalion of the Eleventh Gorkha Rifles of the Infantry, the Battalion which was Commanded by his father. During his distinguished career in the Army, Bipin Rawat commanded an Infantry Battalion along the Line of Actual Control in the Eastern Sector, a Rashtriya Rifles Sector, an Infantry Division in the Kashmir Valley and a Corps in the North East. Bipin Rawat had also commanded a Multinational Brigade in the Democratic Republic of Congo. As an Army Commander, he commanded a theatre of operations along the Western Front and was appointed the Vice Chief of the Army Staff before assuming office of Chief of the Army Staff. The General was the Chief of the Army Staff from 31st December 2016 to 31st December 2019. As a first Chief of Defence Staff Bipin Rawat assumed the charge on 1st January 2020. He was awarded several gallantry and distinguished service awards during his service in the Army. (Source: india.gov.in)

time; eligibility tests/examination like GMAT, SAT, TOFEL and GRE and entrance examination tests for CPL courses/National Defence Academy and Combined Defence Services.

The Scheme will be implemented through reputed coaching institutions/centres. The eligibility criteria for applying for empanelment of coaching institute are the Institute should be registered body or run by an organization registered under the Societies Registration Act, 1860/companies Act 2013 or any other relevant Act of the State/UT. The institute shall also be registered in Darpan portal of NITI Aayog. The institute should have been registered at least for a period of 3 years as on date of notification inviting application from State/UTs/Coaching Institutions for empanelment by the Ministry. The institute should have been fully functional for a minimum period of 3 years at the time of applying under the Scheme. The institute must have proper infrastructure, including provisions for Aadhar based biometric attendance for students and faculty, to meet all requirements for providing coaching in the courses applied for.

The authorized persons of interested coaching Centres have been advised to furnish their willingness along with details and profiles of the organization to the Director (Social Welfare), Goalghar within 30 days.

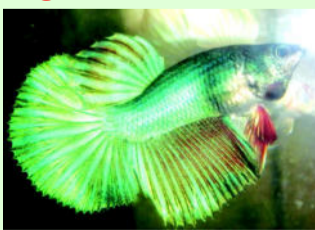

(Siamese fighting fish)**

The Betta fish are air breathers which directly inhale atmospheric oxygen and thrive in deoxygenated stagnant water bodies. There are more than 100 strains of Betta fishes available in the aquarium trade. This species can be easily bred and cultured at home or at commercial scale employing glass tanks, tubs, or cement tanks (2 x 2 meter). The price ranges from 20 to 5000 INR. The Betta fish attains a marketable size within 2 months in these small bottles, and can be fed on a variety of artificial feed. The breeding and seed production for Betta fish is standardized, and can be easily adopted by unemployed youths, women self-help groups, school dropouts and fish farmers..

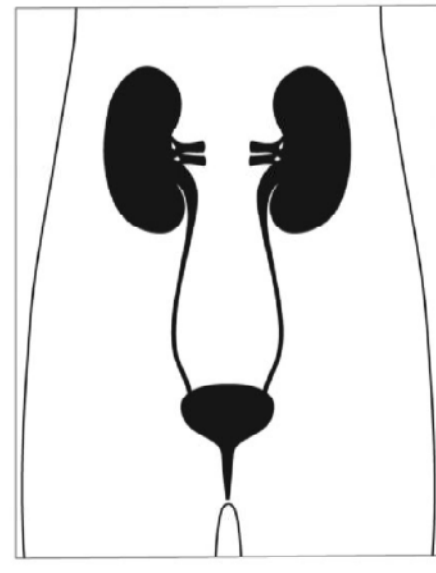
